Focus on kitchen renovation and building expansion. Next step is meeting with PSFA to discuss plan moving forward. Discussion about liaison. ## 5. New Business Matters

### a. Director's Report- presented by Carissa Cantrell, Director.

Family engagement events in this year: currently math and science nights are scheduled with Sandia Labs and Explora.

Enrollment: but spaces are being filled from the lottery. 432 K-5 and 492 prek-5. Talking with families when they disenroll. Personal reasons.

Facility update: working on steps up to the playground. Curb cut to the field. Re-evaluating vendors with landscaping and HVAC.

Safety: Includes alarm upgrade and staff safety procedures.

Communication for families and community: Weekly newsletter, k-12 alerts, and website. Communication for staff: Sunday memo with weekly updates.

Substitutes from ACES are extremely limited- 3 for the Albuquerque area. Contacting another service to see if more substitutes are available and asking our community if they are interested. Asking our educational assistants if they are interested in getting substitute license.

Staffing update/job openings: Ancillary openings are still needed through CES- social worker and occupational therapist. Computer lab teacher resigned. Looking at needs in the office, possible help needed in the business office.

Testing update: Data is available the end of August. Schools have 48 hours to review before data is shared. Data is baseline and will be used to continue instruction.

### b. Membership – new member application\*- presented by Storm Gonzalez

Two new member applications- both are very strong candidates. Christen Hagemann shared insight about one applicant's background and investment in the school. Storm Gonzalez would like to extend invitation to both. Carrie Rodriguez discussed the need for an even board and shared the idea about resigning her position on the board. Accepting both applicants would help Carrie's transition if she were to resign. Balance the roles of members; parents, skills, knowledge, etc. Christen Hagemann motioned to approve the board extending board membership to both applicants; Carrie Rodriguez 2<sup>nd</sup> motion. Roll Call Vote: Christen Hagemann- yes, Carrie Rodriguez-yes, Storm Gonzalez-yes. Unanimous approval.
