- a. Charter Renewal Update- Carissa Cantrell
  - December 12, 2022- Details to come for location and time for public meeting. Preliminary report has been received with three possible inquiries related to English Language Learners and Equity and Identity that will be discussed at renewal hearing. A response was sent back to PED to provide more information. No other areas of inquiry. All other areas meet or exceeds demonstrating progress.
- b. Director's Report Carissa Cantrell
  - Enrollment is at 488 students, pre-k- 5<sup>th</sup> grade. 50 families on our waitlist
  - Campus security continues with access cards for exterior doors.
  - Assessment: Data meetings are tomorrow with grade levels. The below grade level (red) in Istation is getting smaller across grade levels. Parents received access to the parent portal for state assessments. This allows parents to look at individual reports.

- PTO- Turkey Bingo at Holy Family Church for families on Friday. Student bingo during school on Thursday.
- Covid update: Deep cleaning occurs nightly, spot cleaning carpets, teachers are sanitizing throughout the day. We have an extra day porter to help sanitize. At 5% (24 positive cases) we will have to increase safety protocols. We are currently at 6 cases.
- c. School Store/PBIS- Andrea Gallegos
  - Opening day of THE BEARS STORE was November 1, 2022. The store received 236 BEAR BUCKS. Some students spent all their bucks and others decided to save all or some for next time. Items range from 1 buck-20 bucks. More expensive purchases are "experiences" around school with staff members. As of now, the store is open once a month.
- d. Council Trainings Andrea Gallegos
  - Andrea will send a reminder email the first week of each month for upcoming trainings. As trainings are completed, email Andrea the completed hours so they can be logged. We discussed trainings needed for new members and we reviewed the training schedule.
