HAW has a foundation. Lease assistance is based on square footage and enrollment. No update has been provided from PED regarding

2024-2025 school calendar. HAW will create plan A and plan B calendar options. Budget planning will be similar. More than likely funding will not be provided for additional days. As a charter, questions about our charter renewal will be asked and explored if rule passes. Currently PED and PEC approve charters. A lot of unknowns for charter schools, especially HAW since we are chartered as a four-day week school. Budget will be creative. Budgetary cuts may need to occur while keeping kids/student learning as a priority.
